INSTRUCTIONS FOR USE, MAINTENANCE AND WARRANTY CONDITIONS**BEACH LOUNGERS**

1. Product Identification

The beach lounge is intended for recreational sitting or lying, suitable for outdoor or indoor use. It is not suitable for use in strong wind, rain, or very adverse weather conditions.

The maximum recommended load capacity is 100–200 kg (depending on the type of construction).

2. Instructions for Use

Unfolding: Hold the frame firmly with both hands and smoothly unfold it into the desired position. Before each use, check that all braces are properly locked in place, the lounge is stable, correctly secured against accidental folding, and free from any mechanical damage.

Folding: Press the lower part of the frame and carefully fold the lounge. During folding, make sure that your fingers do not get caught between the closing parts of the structure.

Use: Sit down gradually and avoid sudden or heavy impacts, especially when approaching the maximum load capacity. Avoid excessive loading and do not hang any objects on the frame.

3. Maintenance**Fabric cover care:**

- The cover is made of 100% polyester fabric. Clean soiled areas with lukewarm water (max. 60 °C) and a mild soap- or detergent-based cleaning agent
- Do not use products containing bleaching agents or fabric softeners
- Dirt can be removed using a foam sponge or a soft cloth
- After cleaning, rinse the cover with clean water and allow it to dry completely. During drying, do not expose the lounge to direct radiant heat



Frame care:

- Keep the frame clean by gently wiping it with a cloth and a mild soap solution
- Regularly check connecting elements, braces, plastic holders, and the fabric cover. If the frame is damaged or the cover is torn, discontinue use immediately – there is a risk of falling and injury

Storage:

- Before long-term storage, clean the lounger and allow it to dry completely
- Store in a dry place at a relative humidity of up to 60% and a temperature between +5 °C and +40 °C

4. Warnings

- Do not use the lounger in strong wind or other hazardous conditions
- Children, persons with reduced physical or mental capacity, or persons under the influence of alcohol or other addictive substances must not use the lounger without adult supervision
- Take extra care when folding and unfolding – do not place fingers between moving parts of the structure to avoid pinching or injury
- Use only a mechanically undamaged and properly secured lounger
- For frequent outdoor use, regular inspection and servicing are recommended

5. Material, Manufacturing and Graphic Design

- **Fabrics and water resistance:**

The fabrics used are factory-treated with an impregnation that provides increased water repellency. However, these materials are not 100% waterproof

- **Material and color selection:**

If the customer does not explicitly specify the color, type, or method of manufacturing in the order, the manufacturer reserves the right to select a suitable variant based on current material availability and technological possibilities

- **Graphic motifs and seam alignment:**

For printed products, please note that complex or large-scale graphics may not always align precisely across stitched parts and may partially extend into seams or material overlaps. If precise graphic alignment or placement outside seams is required, we recommend preparing a graphic preview or, for larger quantities, a sample, or consulting this requirement in advance with a sales representative or production department

6. Warranty Conditions

6.1 Warranty Period

- **Frame:** 24 months
- **Textile cover and print:** 12 months

The warranty period begins on the date the product is received.

6.2 Warranty Coverage

The warranty covers manufacturing defects in material or workmanship that prevent normal use of the product.

Depending on the nature of the defect, **MONTIS CZ s.r.o.** will provide repair, replacement, or an appropriate price reduction.

The method of claim settlement is determined by the manufacturer.

6.3 Warranty Exclusions

The warranty does not apply to:

- damage caused by improper assembly, handling, or transportation
- use in unsuitable weather conditions
- use of non-original parts, bases, or anchoring systems
- normal wear and tear of materials and color changes caused by UV radiation
- cracks, tears, or damage caused by mechanical stress
- moisture, mold, rust, oils, chemicals, or improper cleaning
- intentional damage, third-party interference, and force majeure events (storms, wind, fire, floods)

Normal fading of the print and slight **color changes after 6 months** of outdoor exposure are considered a natural result of UV exposure and **are not considered defects**.

7. Service and Spare Parts

MONTIS CZ s.r.o. ensures the availability of spare parts and service support during and after the warranty period.

If repair is not feasible, the manufacturer may offer an equivalent replacement or an appropriate price reduction.

8. Final Provisions

These warranty conditions and operating instructions are valid from **1 January 2025** and replace all previous versions.

All legal relationships are governed by Act No. 89/2012 Coll., the Civil Code.

The exercise of warranty rights does not affect the buyer's statutory rights.
